Wanting to apply for a grant? Here are some tips!

- 1. Applications take time.... Prepare in advance
- 2. Make sure your SAM and GATA accounts are up-to-date.
- 3. Some grants require ordinances and policies, so be ready to put them in place.
- 4. Choose projects that are consistent with local plans.
- 5. Do your research! Know your utility rates, assets, or anything that may apply to the grant you are pursuing.

Revolving Loan Fund

Looking to open a business? GWRPC provides low interest loans to area businesses to create or retain private sector jobs. Loans can be between \$10,000 and \$300,000, with one job created per every \$30,000 in loan funds.

Recent Awards

DRA Strategic Planning Grant - New Harmony Bridge

The Illinois New Harmony Bridge Authority has been awarded a Strategic Planning Grant through the Delta Regional Authority (DRA) to help cover preliminary engineering costs for renovation of the New Harmony/Harmony Way Bridge. The \$150,000 grant cannot go toward any construction activities, but the Bridge Authority has submitted and will continue to submit grant applications for funds to cover construction costs, as well. Plans generated from the awarded DRA grant funding will be used in those applications as the Illinois New Harmony Bridge Authority continues in its efforts to rehabilitate and reopen the Harmony Way Bridge.

Lead Service Line Inventory

For many communities, affordability is the biggest hurdle to overcome. To assist communities in meeting the inventory requirements outlined in the LSLRNA, the IEPA is making \$6,570,000 available through the 15% Local Assistance and Other State Program Set-Aside, where no more than 10% of the grant funds may be used on a single program activity. This Set-Aside will be taken from the 2022 BIL- Lead grant to fund this round (Round 4) of the Lead Service Line Inventory Grant Program for the creation of a Complete Lead Service Line Inventory meeting the inventory requirements outlined in 415 ILCS 5/17.12.

Public Infrastructure

Community Development Block Grants

CDBG Project Requirements

- 1. Meet Low or Moderate Income Requirements
- 2. Document a threat to health or safety

3. Have the proper permits. To have the proper permits, an engineer must be hired, surveys must be completed, and permits must be submitted and received.

In order to submit a CDBG grant, the applicant must meet these criteria. Without this information, an application cannot be completed. We recommend planning for applications a year in advance to make sure the application will be completed on time. Applications were submitted this cycle for Albion, Grayville, Bridgeport, and Noble. The application process can be lengthy, so we recommend that planning a year in advance. Contact **Jeff** Vaughan, so we can get started on those applications!

Illinois DCEO Grant Opportunities

States' Economic Development Assistance Program (SEDAP)

Strategic investments in the 252 counties and parishes served by the DRA are helping to improve the quality of life and boost economic development opportunities. The main investment tool used by DRA is SEDAP, which provides direct investment into community based and regional projects that address the DRA's congressionally mandated four funding categories:

- Basic public infrastructure in distressed counties and isolated areas of distress.
- Transportation infrastructure for the purpose of facilitating economic development in the region.
- Business development, with an emphasis on entrepreneurship.
- Job training or employment-related education, with an emphasis on the use of existing public educational institutions located in the region.

SEDAP and all other DRA funding is only available to White County. If interested, contact GWRPC.

Federal Broadband Updates

American Rescue Plan Act (ARPA)

Reporting for Coronavirus State and Local Fiscal Recovery Funds (SLFRF), a part of the American Rescue Plan, is due at the end of April. Entities who have not utilized all of their ARPA funds must obligate those funds by December 31, 2024, and funds must by expended by September 30, 2026 for Surface Transportation and Title I projects. For all other eligible uses, funds must be expended by December 31, 2026.
